

## Call for TILE ARTISTS and EXHIBITORS

### 5<sup>th</sup> Annual Northwest Handmade Tile Festival sponsored by Artisan Tile NW

**The Festival:** An exhibition and sale of contemporary and historic tiles by Northwest artists. The Festival brings together tile artists, collectors, designers, architects and the general public.

**Eligibility:** Any member of ATNW. If you are not a member, join by sending in a check for \$25 along with you application.

**Table fees for Festival:** Full table 30" x 72" -- \$75; Half table -- \$38. Tables are available on a first come/ first serve basis. Tables, black tablecloths and tabletop name signs are provided. Artist supplied racks and display equipment must fit on or behind the table. No refund of table or registration fees for cancellation after September 15.

**Location:** Pioneer Hall, 1642 43<sup>rd</sup> Avenue E, Madison Park, Seattle 98112

**Times and Logistics:** Set up both Festival and Juried Tile Show: Friday, October 1, noon to 4 pm  
Opening reception: Friday, October 1, 5 to 8 pm  
Festival: Saturday, October 2, 10am to 5 pm  
Tear down: Saturday, October 2, 5 to 7 pm

### 5<sup>th</sup> Annual Juried Tile Show sponsored by Artisan Tile NW

**The Juried Tile Show:** Concurrent with the Festival is a Juried Show with the theme "Mythical Creatures," judged this year by Josh Blanc from Minnesota's Handmade Tile Association. You do not need to be an exhibitor in the Festival in order to participate in the Juried Tile Show, but you must be a current ATNW member.

**Theme:** To be eligible for a cash prize your piece must be related to the theme "Mythical Creatures." Each entry must also have an accompanying story or description of around 50 words that relates the work to the show's theme.

**Eligibility:** Any member of ATNW. If you are not a member, join by sending in a check for \$25 along with you application.

**Medium:** Your piece may be made using clay, glass, stone, or metal. It may be a single tile, a multi-tile piece or a tile series, not to exceed 24" x 24". The piece must be handmade by the submitting artist. One entry per artist.

**Sales:** All submissions must be for sale. The artist determines the price. ATNW will take a 40% commission on sales.

**Delivery:** You may bring your piece to the September 23<sup>rd</sup> ATNW meeting or directly to Pioneer Hall on October 1 between the hours of noon and 2 pm. If it is necessary to make other arrangements for delivery, please call Maria Root at 206 328-8076 or Steve Moon at 206 633-4866.

**Application:** Submit a digital image (300 dpi) of your piece by mail on a CD or electronically by email. Label the file on the CD with your last name and write your name on the CD. Include an SASE if you want your CD returned by mail.
